Audit Findings

Audit Narrative

PRE-AUDIT PREPARATION

Prior to the on-site visit, the Agency PREA Coordinator conducted an on-site "pre-audit" of the facility to assess and ensure PREA compliance. That representative had the facility forward to the auditor all policy and supporting documentation, including the completed Pre-Audit Questionnaire, for examination prior to the on-site visit. The policy and documentation was in the form of Volunteers of America-Texas (VOA) policy and other forms/memos, etc. All forwarded documentation and the results of the "pre-audit" were discussed with the auditor prior to the beginning of the audit.

ENTRANCE BRIEFING AND TOUR-FIRST DAY

The on-site PREA (Prison Rape Elimination Act) audit of the Hutchins Residential Re-Entry Center (HRRC), Hutchins, TX, was conducted from June 26-28, 2019. The audit was completed by The Nakamoto Group, Inc. certified auditor William Willingham. This is the second PREA audit for this facility. An entrance meeting was held the first day of the audit to discuss any concerns regarding the audit process and to finalize the facility tour and interview schedules. The following persons were in attendance: the State Director (Facility Director-also PREA Compliance Manager), Assistant Facility Director and the PREA Coordinator. The HRRC is a community level security facility and is considered a work release or "halfway house" program solely for adult males and females. All individuals housed at the HRRC are referred to as "clients". After the entrance meeting, a comprehensive tour of the facility was completed. The tour included the intake processing area, all housing units, recreation, food service, facility support areas, the family visiting areas and programming areas. The auditor observed the facility configuration, location of cameras, staff supervision of clients, housing configurations, including shower/toilet areas, security monitoring, client entrance and search procedures and client program participation. During the tour, it was noted that there was sufficient staffing, security mirrors and surveillance cameras to ensure a safe environment for clients and staff. Clients were able to shower, dress and use the toilet facilities without exposing themselves to employees of the opposite gender. Informal and formal conversations with employees and clients regarding the PREA standards were conducted. Postings regarding PREA violation reporting and the Agency's zero tolerance policy for sexual abuse and sexual harassment were prominently displayed in all housing units, meeting areas and throughout the facility. Audit notice postings with the PREA auditor's contact information were

also located in the same areas. These notices were posted on May 1, 2019. There were no letters mailed to the auditor as a result of the audit postings in the housing units. The facility has been accredited by the American Correctional Association.

STAFF-CLIENT INTERVIEWS-SECOND DAY

A total of thirteen randomly selected facility and correctional staff (referred to as security monitors) were interviewed, including those working the second and third shifts. All were aware of the Agency's zero tolerance policy and their responsibilities to protect clients from sexual abuse/sexual harassment. Additionally, they could explain their new employee and annual PREA training, e-training and their duties as first responders as part of a coordinated response. The Agency Director (designee) and Agency PREA Coordinator were also interviewed. The VOA does not contract with another entity for the incarceration of VOA clients. All specialized staff members were also interviewed, to include the Facility Director, PREA Coordinator, Vice President of Human Resources, the VOA Volunteer Coordinator and intake staff. The facility has no medical staff, no investigators, no contractors or a protective custody unit. One volunteer, a Sexual Abuse Nurse Examiner (SANE) from a local hospital and a community victim advocate were also interviewed. All interviewed staff and the volunteer demonstrated an understanding of the PREA and their responsibilities under this program, relative to their position in or with the organization and employment status. No staff or volunteers refused to be interviewed.

A total of twenty-three clients were selected to be interviewed. The interviewed clients were of various ages, nationalities and ethnic backgrounds. No clients self-identified as being transgender or intersex. One client claimed to be a victim of sexual abuse (at intake), one self-identified as being gay and one self-identified as being bisexual. The facility had no clients who were limited English proficient. One physically disabled client was interviewed. No clients interviewed claimed prior sexual aggression during the intake screening process and one prior victim requested therapy (offered in the community). The rest of the interviewed clients were randomly selected. Overall, all clients interviewed demonstrated a good understanding of the PREA compliance program, the intake screening process, the prevention and protection process and reporting mechanisms (all education requirements under the PREA were met). The clients further stated that staff members were responsive to their needs, female and male staff announced their presence when entering the housing areas and that they felt safe at the facility. No clients refused to be interviewed.

INVESTIGATIONS

There was one PREA related allegation reported within the last year. At the time of the on-site audit, the investigation was still open and had not been completed. The facility does not conduct investigations. Criminal investigations would be conducted by the Hutchins Police Department and administrative investigations by the Residential Re-Entry Office of the Federal Bureau of Prisons or Federal Probation Office.

Facility Characteristics

The Hutchins Residential Re-Entry Center, operated by the Volunteers of America-Texas, is a single-level structure which began serving clients in 1989. The building was originally constructed as a VOA community-based facility commonly known as a "halfway house". The facility is located in an industrial/commercial area of Hutchins, Texas. The program provides housing and around-the-clock supervision for clients demonstrating an inability or unwillingness to function under less restrictive supervision, such as home confinement. Clients can be placed in the HRRC as a condition of probation (Federal) or in a transition from the Federal Bureau of Prisons (BOP). Clients are expected to secure employment and eventually pay a small fee to participate in the program. Clients participate in programming on-site to mainly secure a job, earn funds and secure a residence. Additional services include a continuation of prison-based drug treatment programs, individual assessment programs, employment assistance and housing placement assistance. Clients receive these services at the facility or in the community. Meals are cooked at the facility. Male and female clients have very little contact with each other at the facility. Living areas include male and female separate wings with multiple occupancy dormitory-like rooms with shared showers and bathrooms. There are recreational activities at the facility and religious programs are only available in the community. The facility also has visiting and leisure activity areas.

When the on-site audit was completed, another meeting was held with the PREA Coordinator, Facility Director and Assistant Facility Director to discuss audit findings. The facility was found to be fully compliant with the PREA. Thirty-seven standards were found to be compliant and four were determined to be not-applicable. The not-applicable standards were 115.212,

115.234, 115.235 and 115.271. The auditor had been provided with extensive and lengthy files prior to and during the audit for review to support a conclusion of compliance with the PREA. All interviews and observations also supported compliance. Staff members at the facility were found to be extremely courteous, cooperative and professional. Staff morale appeared to be very good and the observed staff/client relationships were determined to be excellent. All areas of the facility were observed to be clean and reasonably well maintained, especially considering the age of the HRRC. At the conclusion of the audit, the auditor thanked the staff for their hard work and dedication to the PREA audit process.

VOA policy 1200:23A addresses the requirements identified in this standard. The Agency has appointed a Quality Compliance Specialist as PREA Coordinator, who reports to the Chief Programs Officer. The Agency's zero tolerance against sexual abuse is clearly established and the policy also outlines the Agency's approach to preventing, detecting and responding to sexual abuse and sexual harassment allegations. Zero tolerance posters are displayed throughout the facility. Both facility staff and clients are provided with a variety of opportunities to become aware of the PREA. A review of training records and staff interviews confirmed that employees who have regular or frequent contact with clients receive PREA related training during new employee training, on e-learning programs and annually at on-site training. The PREA Coordinator and PREA Compliance Manager were interviewed and advised that they have sufficient time and authority to coordinate efforts to comply with PREA standards. Compliance with this standard was determined through staff and client interviews, the auditor's observation of posters and notifications and policy review. All written documents are available in English and Spanish. Interpretive services are available for clients who do not speak or

read English, Spanish or other languages. All interviews with staff and clients confirmed that each was aware of the zero-tolerance policy towards all forms of sexual abuse/sexual harassment. The commitment to the enforcement and implementation of the PREA meets the required compliance with this standard.

VOA policy 100:16 addresses the requirements of the standard. The Agency's administration, including the PREA Coordinator, reviews the staffing plans on an annual basis and would make adjustments based on the requirements of this standard. Interviews with the Facility Director and the PREA Coordinator revealed compliance with the PREA is a top priority and other safety and security issues are always a primary focus when they consider and review the staffing plan. The auditor reviewed the facility staffing plan and it was determined to be excellent. The facility has been provided with all necessary resources

to support the programs and procedures to ensure compliance with PREA standards. The audit included an examination of all video monitoring systems, design of the facility, potential “blind spots”, client access to telephones, documentation (staffing rosters) and staff interviews. There was sufficient staffing deployment and observation cameras to ensure a safe environment for clients and staff. The review of supervisor unannounced PREA rounds documentation confirmed that intermediate-level or higher-level supervisors conduct and document such visits throughout the institution. Staff are prohibited from alerting other employees regarding unannounced rounds. Interviews with security monitors also confirmed that random, unannounced rounds are conducted by management staff.

VOA policy 1200:23A addresses the requirements of the standard. The HRRC has a rated capacity exceeding 50 clients. The institution does not permit cross-gender strip searches or cross-gender visual body cavity searches under any circumstances. Staff members are trained

to conduct all searches in a professional manner, as confirmed by the auditor's observations of the search procedures and client interviews. Clients, security monitors and administrative staff stated clients are allowed to shower, dress and use the toilet privately without being viewed by the opposite gender. Clients and staff reported that employees of the opposite gender always knock on room doors and announce their presence before entering the housing areas. This practice was observed by the auditor during the facility tour. Staff members were aware of the policy prohibiting the search of transgender or intersex residents to only determine their genital status. Compliance with this standard was determined through staff and client interviews, policy review, auditor observations and a review of the staff training curriculum.

The Human Resource VP would contact all prior employers of prospective employees for information on substantiated allegations of sexual abuse or resignations which

occurred during a pending or confirmed investigation of sexual abuse. The Agency also provides information on substantiated allegations of sexual abuse/sexual harassment on a former employee, when requested from an employer for whom such employee has applied to work, unless prohibited by law. The facility does not provide any on-site medical services. All staff members are trained as first responders to refer victims to a local hospital for medical treatment and the collection of forensic evidence. Medical personnel who are trained to conduct forensic examinations are

on-site at the hospital at all times, as confirmed through contact with the local hospital. The local rape crisis center is willing and able to provide victim advocacy services, as confirmed through contact with the victim advocate. Staff members are also trained to preserve on-site evidence for investigative purposes. Staff also receive refresher training annually and documentation of their participation and understanding is on file. The auditor reviewed the training lesson plan and training sign-in sheets. Staff interviewed also confirmed compliance with this standard.

There is no Collective Bargaining Agreement between the HRRC and the staff. Policy allows for disciplinary sanctions against staff including termination for sexual abuse or sexual harassment of a client.
