## Official Rules of Entry 2021 Golfstar Prize Raffle

- Tickets will be sold for \$20 for one, or \$50 for three.

  - Runner-up Prize – Signed Joe Burrow LSU jersey
  - Third Place Prize – \$500 Cash Prize
- Only official and legible ticket entries containing the legible name, email address and/or phone number of the entrant are eligible for the drawing. No facsimiles are permitted.

  - > **At Volunteers of America sponsored events:** All other events held by Volunteers of America with regards to this raffle including but not limited to the Volunteers of America Golfstar Classic held on March 9, 2021.
- Winner will be determined in a random drawing to be held at the Volunteers of America Golfstar Classic on March 9, 2021, at or before 5:00 p.m.
- Winner need not be present to win and will be notified by phone if not present.

- Each ticket only eligible to win once.
